



Parking Regulations

relating to the car parks at the BMW International Open 2024

§ 1 Scope of Application

1. Visitors shall hereby accept the Parking Regulations when they drive into or enter the car park. This provision shall apply to all parking areas which the organizer of the BMW International Open has designated around the event venue.

§ 2 Entry and Parking Authorization

1. There shall be no right to the availability of a parking space, especially if the capacities of the parking areas are full.
2. The parking areas shall be opened as required and shall be assigned to the visitors by the stewards.
3. The right to use the parking areas shall cease to apply if the parked vehicle is not covered by liability insurance and/or its registration number has been cancelled and/or it does not have an official registration number with a valid inspection plate and/or the vehicle was parked with a leaking tank/engine or else in a non-roadworthy condition or a state which might pose a risk.
4. Parked vehicles may not contain any items which pose a danger to other visitors.

§ 3 Road Traffic Regulations and Behavior in the Parking Areas

1. The latest versions of the Road Traffic Regulations (StVO) and the Road Traffic Licensing Regulations (StVZO) shall apply in the parking areas.
2. Vehicles may only be parked in approved and designated parking areas. Vehicles which are parked outside designated parking areas or block access on roads or escape routes, may be towed away without prior warning. The fees incurred in this case shall be paid by the responsible driver.
3. Cars shall always be driven at walking speed in the area of car parks.
4. Drivers shall not let their engine run or move their car unnecessarily on the parking areas.
5. Paths, installations and other facilities on the parking areas shall be kept clean and treated properly.
6. All persons shall be requested not to throw away rubbish, packaging materials and empty containers, but to dispose of them in the available rubbish bins.
7. Every visitor shall behave in such a way that nobody else is injured, endangered or - more than is unavoidable under the circumstances - hindered or burdened.
8. The parking areas may only be entered and exited via the designated entrances and exits.



§ 4 Security Service

1. The parked vehicles shall not be guarded. Drivers shall park vehicles at their own risk. The utilized security staff shall issue instructions, they shall not guard the vehicles.
2. Visitors are hereby instructed not to leave any money, bank and credit cards or other valuables as child's or dogs unattended in their car.
3. The visitors shall comply with the instructions of the security staff, the organizer's employees, other persons appointed by the organizer, the police, the fire brigade and the emergency and medical service. This provision shall also apply to instructions which are announced via loudspeakers.

§ 5 Infringements

1. Persons who contravene these Parking Regulations or do not observe the instructions and orders of the security staff, the organizer's employees, other persons appointed by the organizer, the police, fire brigade and the emergency and medical services, may be prevented from entering the parking areas or ejected therefrom by the security staff and the police. Affected vehicles may be towed away in this case without prior warning. The responsible driver shall pay the fees incurred in this case. The organizer and the security staff shall reserve the right in these cases to file a criminal complaint due to trespass.
2. In the event of serious or repeated infringements, the person concerned may be banned from the event for its remaining duration.

§ 6 Liability

1. The organizer will not be liable for any damage to cars on the parking spaces. Please note that you use the parking spaces at your own risk.
2. The organizer shall only be liable in the case of intent or gross negligence for damage caused by the infringement of contractual or non-contractual obligations, especially due to unauthorized action. The above-mentioned liability restriction shall not apply to loss of life, physical injury or damage to health.
3. The above-mentioned liability restriction shall apply to the same extent to the organizer's subcontractors and vicarious agents.
4. The above regulations shall not involve a change in the burden of proof to the disadvantage of the event visitor.
5. Injured or damaged persons shall contact the organizer immediately to report the injuries/damage

§ 7 Final Provisions

1. These Parking Regulations shall come into force at 7 am on 1 July 2024 and shall apply until 7 am on 8 July 2024.
2. The Parking Regulations shall form an integral part of the authorization to access the tournament and shall be published as part of ticket purchase or confirmation of accreditation.
3. The provisions arising from the Site Regulations shall apply in addition to the Parking Regulations.
